Topic Background:

Months after the Japanese attack on Pearl Harbor, President Franklin D. Roosevelt issued Executive Order 9066, which authorized the evacuation and relocation of "any and all persons" from "military areas." Within months, all of California and much of Washington and Oregon had been declared military areas. The process of relocating thousands of Japanese Americans began. Japanese Americans were required to register and received identification numbers. They were given just days to divest themselves of all that they owned, including businesses and family homes. Bringing only what they could carry, they were told to report to assembly centers: large facilities like racetracks and fairgrounds while they waited to be assigned and sent to a war relocation center, such as Manzanar.
